"RESOLUTION FOR THE CREATION OF RJJWC ARMM MONITORING TEAM"

Republic Act 9344, as amended, provides the legal basis for the creation of the WHEREAS, Juvenile Justice and Welfare Council (JJWC), the inter-agency body mandated to formulate and develop policy, coordinate and monitor the implementation of the

Juvenile Justice and Welfare Act (JJWA),

Republic Act 9344, as amended by Republic Act 10630, mandated the Regional WHEREAS, Juvenile Justice and Welfare Committee (RJJWC) to formulate policies and develop programs on juvenile justice and welfare and to continue to review, formulate and adopt plans, policies, rules and regulations, to ensure the effective and efficient

implementation of the Juvenile Justice and Welfare Act;

Sec 9.Rule 14.g. of the Revised IRR of R.A. 9344 as amended clearly states that the WHEREAS, RJJWC through duly designated persons and with the assistance of the agencies provided in the preceding section, to conduct regular inspections in detention and rehabilitation facilities within the region and to undertake spot inspections on their

own initiative in order to check compliance with the standards provided herein and to make the necessary reports and recommendations to appropriate agencies and

to the JJWC;

RJJWC ARMM convened regular meeting to discuss the situation CICL found in WHEREAS, detention facilities with adult inmates, the committee meeting held last November

9, 2018 at which a quorum was present and agreed by the members;

WHEREFORE, Be it hereby resolved by the Regional Juvenile Justice and Welfare Committee to formally create RJJWC Monitoring Team. The team shall be composed of representative from DSWD, DILG, DOH, RPDO, RHRC, PAO, PNP, DEPED and

partner NGO.
