"Resolution for the inclusion of Community and Family Services International- a Non-government Organization as RJJWC partner NGO"

Republic Act 9344, as amended, provides the legal basis for the creation of the Juvenile WHEREAS, Justice and Welfare Council (JJWC), the inter-agency body mandated to formulate and develop policy, coordinate and monitor the implementation of the Juvenile Justice and

Welfare Act (JJWA),

Republic Act 9344, as amended by Republic Act 10630, mandated the Juvenile WHEREAS.

Justice and Welfare Council (JJWC) to formulate policies and develop programs on juvenile justice and welfare and to continue to review, formulate and adopt plans, policies, rules and regulations, to ensure the effective and efficient implementation

of the Juvenile Justice and Welfare Act;

Rule 12.a. of the Revised IRR of R.A. 9344 as amended clearly states that the RJJWC WHEREAS,

shall be composed of permanent representatives from line agencies and one representative from each of the two (2) NGOs working with children-at-risk and children in conflict with the law, engaged in children's rights advocacy and

operating within the Region.
