## COUNCIL RESOLUTION NO. 8

Series of 2007

**WHEREAS**, during the 9<sup>th</sup> regular meeting of the Juvenile Justice and Welfare Council (JJWC) held on 24 April 2007, one of the proposals discussed was the **Staffing Pattern of the JJWC Secretariat**, which is needed for the effective implementation of R.A. 9344, otherwise known as the "Juvenile Justice and Welfare Act of 2006",

**WHEREAS**, the JJWC discussed the plantilla/positions needed for the office and arrived at the conclusion that it shall be headed by an Executive Director III, with three (3) Divisions, namely: Policy Plans and Programs Division; Administrative and Financial Division, and the Management Information System Division, each to be headed by a Division Chief with the corresponding support staff for the efficient and effective operation of the office; per attached copy of the plantilla;

**WHEREAS**, the funding for the said positions including that of the support staff and other services requirements, shall be taken from the FIFTY MILLION ( P50,000,000.00) PESOS initial fund provided by the law (Section 6, RA 9344) principally for the purpose of setting up the JJWC office;

**WHEREAS**, in view of the urgent need for the office to be operational enabling it perform its functions properly and effectively, the members of the Council, after evaluation of the proposed plantilla and funding requirements, were unanimous in the approval thereof.

**FOREGOING CONSIDERED**, the Council resolves, at it is hereby resolved, to formally approve and adopt the proposed plantilla and the corresponding funding requirements therefor for a functioning and effective JJWC office.


